<u>Periodontology</u> (From 4 to 6 seats if granted on or after 12.5.2015).	MDS (Periodontology) Rajiv Gandhi University of Health Sciences, Bangalore.

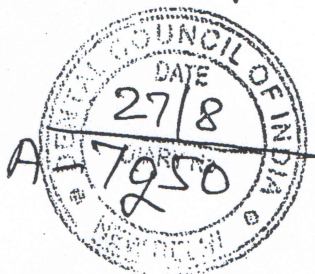
